Attended Funeral	Not Offered
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
<ul style="list-style-type: none"> • Taking care of all necessary legal and administrative arrangements - • Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care - • Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at [both] the funeral director's [branch premises] [and at other] [non branch premises] - • Providing a suitable coffin – this will be made from [insert description of the coffin] - • Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer) - • At a date and time, you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle - 	
Unattended Funeral	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the cremation itself.
